Sir,

CBI, ACB, Chennai has 12 vacancies in the rank of Police Inspector which are to be filled on deputation basis from various Central Govt. organizations like Central Excise, Customs, Income Tax, State Police Forces and other Dept.

In this connection, it is to inform that as per the recruitment rules, Inspector of Central Excise and Custom or Preventive Officers Grade - I or Examiner in Custom Office or Income Tax Inspectors or persons working in the analogous post on regular basis under the State Govt. and possessing at least five years executive experience in Vigilance or Investigation or Intelligence Work & having Graduation from recognized university are eligible for applying for deputation in CBI.

The Officers joining on deputation as Police inspectors in CBI are eligible for:-

1. SSA - Special Security Allowance @ 20% of the Basic Pay.
2. Cash Compensation for working on Saturdays/Holidays @ 2 ½ days for every completed month of service subject to maximum of 30 days in a year. Hence actually they draw 13 months pay in a year.
3. Ad-hoc Bonus.
4. Children Education Allowance upto Rs. 27,000/- per child (for 02 children).
5. CGHS (Medical) facilities.
6. Membership of CBI Benevolent Fund.
7. Central Police Canteen facilities and other facilities as per Central Govt. Employee.


