केंद्रीय अप्रत्यक्ष कर एवं सीमा शुल्क बोर्ड (सीबीआईसी), नई दिल्ली ने पत्र F.No.A.1 2034/SSC/07/2022 -Ad.III.B दिनांक 08.08.2023 के माध्यम से कर्मचारी चयन आयोग द्वारा आयोजित संयुक्त स्नातक स्तरीय परीक्षा, 2022 के परिणामों के आधार पर चेन्नई वस्तु और सेवा कर अंचल में निरीक्षक (वस्तु और सेवा कर तथा केन्द्रीय उत्पाद शुल्क) के पद पर 193 अभ्यर्थियों को आवंटित किया है।

The Central Board of Indirect Taxes and Customs (CBIC), New Delhi vide letter F.No.A.12034/SSC/07/2022 -Ad.III.B dated 08.08.2023 has allocated 193 candidates for the post of Inspector (GST & Central Excise) to Chennai GST Zone based on the results of the Combined Graduate Level Examination, 2022 conducted by Staff Selection Commission.

The document verification & PET **will be held on 07.09.2023 (Thursday), 08.09.2023 (Friday) and 09.09.2023 (Saturday).** Hence, candidates are advised to plan their itinerary for at least 3 days so as to attend DV & PET. Candidates are requested to bring shoes for the Physical Test. The process of Document Verification is subject to receipt and verification of dossiers by the Cadre Controlling Authority, Chennai Zone.
