Sub: Appointment of Grievance Redressal Officer for Persons with Disabilities in the grade of Group B and C in the GST & Central Excise, Chennai Cadre Control Zone – reg.

In terms of the Rights of Persons with Disabilities Act, 2016 read with the Equal Opportunity Policy communicated in Board's letter F.No.C.50/39/2021-Ad.II dated 04.05.2023, Shri.
