Sub: Appointment of Grievance Redressal Officer for Persons with Disabilities in the grade of Group B and C in the GST & Central Excise, Chennai Cadre Control Zone – reg.

In terms of the Rights of Persons with Disabilities Act, 2016 read with the Equal Opportunity Policy communicated in Board's letter F.No.C.50/39/2021-Ad.II dated 04.05.2023, Shri. Parry Vallal, Additional Commissioner, is nominated as the Grievance Redressal Officer in respect of Group B and C (Gazetted and non-Gazetted) officers in Chennai Cadre Control Zone.

2. The Officer shall be the nodal point for receiving and disposing of all grievances filed under this policy. He shall maintain a register of complaints in the manner as prescribed by the Central Government. The Grievance Redressal Officer shall investigate the complaint and take up the matter with the establishment for corrective action. Complaints shall be inquired within two weeks of its registration.
