केंद्रीय अप्रत्यक्ष कर एवं सीमा शुल्क बोर्ड (सीबीआईसी), नई दिल्ली ने पत्र F.No.A.1 2034/SSC/13/2021 -Ad.III.B दिनांक 02.05.2023 के माध्यम से कर्मचारी चयन आयोग द्वारा आयोजित संयुक्त स्नातक स्तरीय परीक्षा, 2021 के परिणामों के आधार पर चेन्नई वस्तु और सेवा कर अंचल में निरीक्षक (वस्तु और सेवा कर तथा केन्द्रीय उत्पाद शुल्क) के पद पर 99 अभ्यर्थियों को आवंटित किया है।

The Central Board of Indirect Taxes and Customs (CBIC), New Delhi vide letter F.No.A.1 2034/SSC/13/2021 -Ad.III.B dated 02.05.2023 has allocated 99 candidates for the post of Inspector (GST & Central Excise) to Chennai GST Zone based on the results of the Combined Graduate Level Examination, 2021, conducted by Staff Selection Commission.
