2. The First Nominated Link Officer, and, in his absence, the Second Nominated Link Officer, as detailed above shall stand assigned the additional charge of the respective Officer mentioned in Col. (2) of Table-1 to Table-3 above whenever the Officer mentioned in Col. (2) of Table-1 to Table-3 above proceed on tour, leave, election duty, training or is absent for any reason etc..

3. In terms of Board's Officer Order No: 04/2017 dated 13.07.2017 (issued from F.No.390/Review/49/2017-JC), the Principal Commissioner / Commissioner being assigned the administrative charge of the Commissionerate i.e., the First Nominated Link Officer & in his absence the Second Nominated Link Officer (**Table-1 above**) would function as member of the **Committee of Commissioners /Principal Commissioners** for the purpose of review of orders passed by Commissioner (Appeals).

4. With the above arrangement for Link Officers, **no separate orders for assigning additional charge** would be issued whenever an Officer mentioned above proceeds on tour, leave, election duty, training or is absent for any reason etc.

5. Formal handing over of charge should take place wherever feasible, especially if the relieving officer is expected to discharge statutory duties such as adjudications, appeals, prosecution sanction etc.

6. On the same lines above, the Commissioners / Pr. Commissioners excluding Appeals Commissionerates are directed to notify a link officer system at all levels and in all offices under their jurisdiction.
