- O3. The Seniority of the officers will be fixed as per the orders in force.
- 04. The officers promoted on Regular basis, mentioned at para No.1 above, should exercise their option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining as Superintendent. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

This fact may be brought to the notice of the Cadre Control Authority immediately.
  - 08. The promotion now issued is subject to the condition that the officers concerned join latest by 20.09.2023 in their nominated place of posting failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.
