- 02. On assumption of charge as Superintendent in Central GST and Central Excise, Tamil Nadu & Puducherry Zone, the promoted officers will continue to work in their present place of posting until regular posting orders are issued.
- O3. However, the officers mentioned in table above who are working on Deputation basis / Loan basis, have to repatriate back to CCA, Chennai for assuming charge as Superintendent in CCA-Estt section, Office of the Principal Chief Commissioner of GST & Central Excise, Chennai 600 034. In terms of G.I. Dept. of Per.& Trg., O.M. No. 16/7/90-Estt.(Pay-I), dated the 9th September 1992 and 20th March, 1995 their controlling officers are required to relieve them immediately on receipt of this order of promotion. Their promotion will be effective only on joining this office and the delay in relieving them from deputation / loan will cause the officer pecuniary loss.
- 04. The Seniority of the officers will be fixed as per the orders in force.
- 05. The officers promoted on Regular basis should exercise their option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining as Superintendent. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.
- 06. The promotion now ordered is subject to outcome of the followings.
  - (i) Writ Petition in W.P.C.T. 261/2008 filed by Shri Samiran Roy & Others pending before the Hon'ble High Court, Calcutta in terms of Board's letter F.No.C-18012/6/2009 Ad IIB dated 16.09.2010.
  - (ii) Jarnail Singh batch of cases in SLP (C) No.30621 of 2011 pending in Hon'ble Supreme Court of India.
  - (iii) Other cases, if any, pending before any judicial fora.
- 07. Further, the controlling officer concerned shall ensure that if the Inspector

whose name is figuring in this promotion order is under suspension /undergoing disciplinary or prosecution proceedings/ is under penalty period etc, such officer should not be relieved or allowed to assume charge as Superintendent and the fact should be brought to the notice of the Cadre Control Authority immediately.

- 0 8 . The promotion now issued is subject to the condition that the officers concerned shall assume charge as Superintendent in Central GST and Central Excise, Tamil Nadu & Puducherry Zone latest by 12.02.2024. If an officer does not want to accept the promotion, he may make a written request and if the reasons adduced for refusal of promotion are acceptable to the Appointing Authority, the request will be considered by the Appointing Authority, taking relevant aspects into consideration.
- 09. The compliance report about the joining/non-joining of the officers on promotion to the higher grade should be sent to this office by the concerned Commissionerate of this Zone by 14.02.2024.
- 10. This order is issued with the approval of Principal Chief Commissioner, GST & Central Excise, Tamil Nadu and Puducherry Zone.
