A Review DPC for promotion to the grade of Superintendent for the vacancy year 2002-03 was held on 28.12.2023, to implement the Interim order dated 17.04.2023 of the Hon'ble CAT Chennai Bench in MA No.139/2023 in OA No.533/2018 filed by Shri P. Naresh Kumar Reddy and Shri N. K Raja and as directed in Board's letters F.No.C-18011/12/2022-Ad.II dated 24.11.2023, 05.12.2023 & 26.12.2023.

2. Consequent to the present DPC, the promotion of Shri N K Raja (Emp Code-4603) (Retired from Chennai Audit-I Commissionerate) to the grade of Superintendent is reckoned with effect from 23.09.2002 on notional basis (i.e the date of promotion of his junior in General Category viz Shri R Govindan).

3. Further, in the Zonal Seniority list of Superintendents, Shri N K Raja (Emp-Code-4603) will be placed below Shri S Rammohan (Emp Code-3514) and above Shri R Govindan (Emp Code-1844)

4. Further, as observed by the Hon'ble High Court, vide Interim Order dated 13.03.2017 in WMPNo.27508 and 27508/2016 filed by Shri. S. Rajagopalan & others and in W.P.No.11580-11581/2006 filed by the department, directed (in para 24) that the notional promotion now accorded to the petitioners will be subject to the finalisation of the Writ Petition Nos. 11580 & 11581 of 2006 filed by the Department and W.P.No.15368 and 15369 of 2006 filed by Shri.M.Jegannathan & Others. Also, as per the Hon'ble Supreme Court Order dated 09.10.2017, no one ought to be reverted and the position of the officers belonging to reserved category who had been

promoted due to implementation of own merit remains unaltered and the decision of the present DPC is subject to the final outcome of the Jarnail Singh batch of cases (in SLC (C) No.30621 of 2011
