- 02. The promoted officers will continue to work in their present place of posting until regular posting orders are issued. However, the promoted officers working on Deputation basis / Loan basis should repatriate back to CCA, Chennai for assuming charge as Superintendent in CCA-Estt section, Office of the Principal Chief Commissioner of GST & Central Excise, Chennai 600 034. Their promotion will be effective only on assuming charge as Superintendent in this office.
- 03. The Seniority of the officers will be fixed as per the orders in force.
- 04. The officers promoted on Regular basis should exercise their option for fixation of pay in terms of F.R.22 (I) (a)(1) within one month from the date of issue of this order. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

- 05. The promotion now ordered is subject to outcome of the followings.
 - (i) Writ Petition in W.P.C.T. 261/2008 filed by Shri Samiran Roy & Others pending before the Hon'ble High Court, Calcutta in terms of Board's letter F.No.C-18012/6/2009 Ad IIB dated 16.09.2010.
 - (ii) Jarnail Singh batch of cases in SLP (C) No.30621 of 2011 pending in Hon'ble Supreme Court of India.
 - (iii) Other cases, if any, pending before any judicial fora.
- 06. Further, the (Pr.) Commissioners concerned shall ensure that if the Inspector whose name figuring in this promotion order is under suspension or facing any Disciplinary proceedings or prosecution or under penalty period, such officer should not be relieved or allowed to assume charge as Superintendent. This fact may be brought to the notice of the Cadre Control Authority immediately.
- 07. The promotion now issued is subject to the condition that the officers who are promoted with effect from 01.01.2024 shall join latest by 10.01.2024 failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow. Further, the officers promoted after their debarment period shall join within 10 days from their effective date of promotion failing which it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow
- 08. The compliance report about the joining/non-joining of the officers should be sent to this office by the concerned Commissionerate positively by 06.02.2024.
