04. The promoted Havalgars may exercise their option for fixation of pay under FR 22(I)(a)(1) within one month from the date of issue of this order. However, if the officer has been granted financial upgradation under ACP/MACP scheme prior to promotion he is not entitled to any pay fixation benefits now.

05. The Seniority of the promoted officers in the grade of Head Havalgar will be fixed as per the orders in force.
