

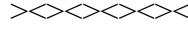

03. The above promoted officers **will be considered for rotation / transfer during AGT 2024 as per prevailing Transfer Policy.**

04. The Seniority of the promoted officers in the grade of Executive Assistant will be fixed as per the orders in force.

05. The officers promoted on Regular basis, mentioned at para No.1 above, should exercise their option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining as Executive Assistant. The officers who have already been granted financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

06. The promotion now ordered is subject to outcome of the followings:

07. All the promoted officers should join immediately but not later than 27-10-2023. If the officers fail to join on or before the said date, it will be treated that they have not accepted the promotion *ab initio* and all consequences arising as a result of non-acceptance of promotion shall follow.
