Sub : Promotion, Posting and Transfer in the grade of
Senior Private Secretary - Regarding.

Consequent to the Supplementary DPC for the year 2023 held on 22.12.2023, the following Private Secretaries are promoted on Regular Basis to the grade of Senior Private Secretary (Group 'B' Gazetted) in Level - 8 in the Pay Matrix of 7th Pay Commission on an in situ basis. The promotion now ordered will be effective from the date the promoted officers assume charge as Senior Private Secretary :

02. The Seniority of the promoted officers in the grade of Senior Private Secretary will be fixed as per the orders in force.

The officers promoted on Regular basis mentioned, should exercise their option for fixation of pay in terms of F.R.22(I)(a)(1) within one month from the date of joining as Senior Private Secretary. The officers who have already been granted Financial upgradation under Assured Career Progression Scheme / Modified Assured Career Progression Scheme are not entitled for pay fixation benefits now.

04. The promotion now ordered is subject to outcome of the followings :

(i) Writ Petition in W.P.C.T. 261/2008 filed by Shri.Samiran Roy & Others pending before the Hon'ble High Court, Calcutta in terms of Board's letter F.No.C-18012/6/2009 Ad IIIB dated 16-09-2010.

(ii) Jarnail Singh and Ors. V. Lachhmi Narain Gupta and Ors. (Civil Appeal No.629 of 2022 arising out of SLC (C) No.30621 of 2011) and batch in SLP© NO.30621 of 2011 pending in Hon'ble Supreme Court of India.

(iii) Other cases, if any, pending before any judicial fora.

05 The promotion now issued is subject to the condition that the officers concerned join latest by 29-12-2023 failing which it will be treated that they have not accepted the promotion *abinitio* and all consequences arising as a result of non-acceptance of promotion shall follow.
