However, if the officer has been granted financial upgradation under ACP/ MACP scheme prior to promotion he is not entitled for any pay fixation benefits now.
- 5. The Seniority of the promoted officer in the grade of Lower Division Clerk will be fixed as per the orders in force.
- 6. The compliance report regarding their joining should be sent by 10.01,2023.
