03. All the officers are posted in the same formation until ensuing AGT. They would be considered for deployment as per the Transfer policy during AGT-2023.
04. The promoted Havaldars may exercise their option for fixation of pay under FR 22(1) (a)(i) within one month from the date of receipt of this order. However, if the officer has been granted financial up gradation under ACP/MACP scheme prior to promotion he is not entitled for any pay fixation benefits now.
05. The Seniority of the promoted officers in the grade of Head Havaldar will be fixed as per the orders in force.
06. The promotion now ordered is subject to outcome of the following:
- (i) W.P.C.T.No.261/2008 filed by Samiran Roy and others before the Hon'ble High Court of Calcutta in terms of Board's letter F.No.C-18012/6/2009.Ad.III.B dated 16.09.2010,
- (ii) Further orders that may be passed by the Hon'ble Supreme Court of India in the said batch of cases, since the Jarnail Singh batch of cases in SLC(C) No.30621 of 2011 is pending.
- (iii) Any other pending cases, before any judicial fora.
